Whereas, with the arrival of another cold weather season in Four Seasons Country, it's good for everyone to remain vigilant concerning the potential of residential and commercial structure fires. Today, the Mercer County Commission recognizes a county employee whose alert actions most likely prevented serious injury to a family and their pets; and,

Whereas, Karen Rutledge, a member of the Mercer County Commission's evening shift custodial staff, noticed smoke coming from a Princeton residence. At first, she thought to herself that it was too cold for the family to be outside cooking on their grill — something that they frequently do in the summer months—but as she was looking a large flame burst through the roof of the home; and,

Whereas, Ms. Rutledge knew the family, because when the evening shift were outside eating lunch at the picnic tables at the courthouse annex, the children would bring their pets and visit with evening shift employees; and,

Whereas, Ms. Rutledge ran to the house and shouted through the screen door that the house was on fire, and for them to gather up their pets and get out immediately. She said that she didn't call 911 immediately. "I just wanted them to get the kids out and to save their pets," Ms. Rutledge said; and,

Whereas, the Princeton Fire Department received the call at 8:04:29 pm, and arrived in three-and-one-half minutes, Ms. Rutledge said she didn't know who called the fire department, but she was thankful that they arrived. Firefighters were able to save the structure, and the homeowners have removed their smoke & fire-damaged possessions, have had the roof replaced and are hoping to move back in soon.

Now, Therefore, Be It Resolved that the Mercer County Commission commends Ms. Rutledge for her quick reaction to what might have become a tragedy with two adults, four children and several pets residing in the home. Thanks also to the quick response by the Princeton Fire Department for their role in saving lives and preventing extensive property damage, Now,

Further, Be It Resolved that the Mercer County Commission expresses its heartfelt thanks to Karen Rutledge for her quick response in assisting this family. Also, this Commission wishes to express its thanks to both the paid and volunteer fire departments of Mercer County who stand ready to assist any and all of the families who need them in any and every emergency situation
