Dear Mike,

It is possible that none of us truly understood the broad-reaching impact of a decade or more of mismanagement in our Sheriff's Tax Office, but the resolution is far more complex than Mercer County or Software Solutions could have anticipated. It will likely take months before investigators complete their work, but Mercer County needs assistance to prepare for the ongoing challenge of the never-ending cycle of taxation WITH representation.

The topic of our Tax Office came up on March 9, 2023 during our annual budget meetings. We all appreciate Software System's on-going help to get this year's Sheriff's Settlement finished. However, and this is a big however, our Chief Field Deputy as well as this Commission expressed frustration concerning the prolonged incompletion of the project as well as our staff – Georgia Bailey and Jessica Tibbs – and their concerns that the training period promised in the contract didn't take place due to the enormous aforementioned tax office quagmire. Tax office staff, administration and commission appreciate Judy Moody and Reva Scoonover's efforts, but the consensus has been that the contract remains far from complete and our clock is ticking.

This Commission understands businesses encounter unanticipated challenges, but this Commission also understands that businesses can take additional steps to meet their contractual obligation. This Commission would like Software Solutions to take immediate steps to meet our expectations of both completing our FY-22 Settlement as well as to provide a concrete date for training on the system to prepare tax office personnel to fully acclimate them in preparation for the FY-23 settlement.
